# The Passmore Group's Privacy Statement Regarding Prospect and Customer Information

This Privacy Statement Regarding Customer Information ("Privacy Statement") applies to the Passmore Group, the trading name of B&K Passmore Limited and covering the brands of More Bathrooms, More Ability and More Build. This Privacy Statement also does not apply to any other third parties.

This Privacy Statement governs Personal Information we collect from our prospects and customers.

For the purposes of this Privacy Statement, "Business Partner" means any subcontractor, vendor or other entity with whom we have an ongoing business relationship to provide products, services or information. "Personal Information" means information that may directly or indirectly identify you, such as your name, telephone number, email address and address.

#### 1.0 INFORMATION WE COLLECT ABOUT YOU

We may ask you to provide Personal Information when you:

- Use our website
- Request quotes, services, information guides, brochures, newsletters or other information;
- Place orders for products or services or register for / at events, exhibitions and competitions;
- Create and manage an account;
- Participate in surveys or other promotional activities online or in any other venue;
- Provide a testimonial;
- Subscribe to newsletters, marketing and promotional emails or other materials;
- Interact with us on third party social networks (subject to that third party's terms of use and privacy policies); or
- Contact us

Categories of Personal Information we collect may include;

- Your name
- Email address
- Home address
- Contact telephone numbers including mobile
- Site Address
- Job Title
- Company
- Support Workers, Carers or key family members

Health related information may also be requested if relevant to the service we are providing.

Forms that you choose to complete will indicate whether information requested is mandatory or voluntary. If you make a purchase, we may ask for your debit card number and billing information.

Passmore Group services may be presented under one of our three core brands More Ability, More Bathrooms and More Build. Your details are available across these brands as part of the central Passmore Group database.

You are able to request details about this data and its removal at any point of the process.

Data collected will not be shared with 3<sup>rd</sup> parties unless they are part of the service delivery or a trusted partner of Passmore Group.

#### 2.0 HOW WE USE YOUR PERSONAL INFORMATION

Passmore may use your personal information to;

- Deliver the products, solutions, services and support or carry out the transactions you have requested;
- Send communications to you, including information about your order, installation job, warranties and referral programs. We may also send our monthly newsletter and additional information about our range of services. You may opt out of such communications at any point;
- Customise, analyse and improve our products, solutions, services (including the content
  and advertisements on our website to identify usage trends or determine the
  effectiveness of our marketing campaigns), technologies, communications and
  relationship with you;
- Better understand our customers, including profiling based on services take;
- Personalise content and implement your preferences;
- Enforce our conditions of sale, website terms and separate contracts (if applicable) with you;
- Prevent fraud and other prohibited or illegal activities;
- Protect the security or integrity of our websites, our businesses, and our products or services; or
- Perform other functions or serve other purposes, as disclosed to you at the point of collection, or as required or permitted by law.

# 2.1 Legal Basis of Processing

Our legal basis for collecting and using your Personal Information as described in this Privacy Statement will depend on the Personal Information concerned and the specific context in which we collect it. In general, we collect and process your Personal Information on one or more of the following bases:

- Your consent, for example where we have obtained your consent to process your personal data for certain activities such as sending guides and attending surveys. You are free to withdraw your consent at any time by contacting <a href="mayler:mydata@passmoregroup.co.uk">mydata@passmoregroup.co.uk</a>. If you withdraw your consent, it will not affect the lawfulness of any processing based on your consent before you withdrew it. Where applicable, we may ask for your consent to processing at the point where you provide your personal information.
- To comply with a contractual obligation (for example, using your address to send a fitter
  to site to install product purchased from us or using your personal details where you have
  asked us to do something before making a purchase, such as providing you with a quote).
  We will advise you upon collection whether the provision of your personal information is
  mandatory and of the possible consequences if you do not provide us with your
  information.
- For compliance where other laws require the processing of your personal information (for example, health and safety, taxation and anti-money laundering laws) or where we need your personal information to protect your vital interests or those of another person.
- Passmore Group's legitimate interests which include the provision of relevant products and services, and/or the carrying out of marketing and profiling activities, provided always that our legitimate interests are not outweighed by any prejudice or harm your rights and freedoms.

## 2.3 Retention of your data

We will retain your Personal Information as necessary in connection with the purposes described in this Privacy Statement, for as long as your account is active

#### 3.0 HOW WE MAY SHARE YOUR PERSONAL DATA

We will only share your Personal Information with associates who agree to protect your Personal Information and use it solely for the purposes specified by Passmore. This includes our IT Support firm, accountants and software providers.

We may disclose your Personal Information for any purpose with your consent.

We may also disclose your Personal Information in connection with law enforcement, fraud prevention or other legal action; as required by law or regulation; if Passmore Group merges with another company; or if Passmore reasonably believes it is necessary to protect Passmore, its customers or the public.

We may share your information with trusted review sites and social media platforms with your consent

Except as described above, we will not disclose your Personal Information to third parties for their own marketing purposes without your consent.
